NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS: **CLAUSE 1:CO-OPERATION**

- 8. The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2:SCOPE OF THE MoU

- 18. Placements: Second party will actively engage to help the delivery of training and placement of the students of the first party as per the company requirements.
- 19. **Internships:** Second party will engage to provide internship training to the students of first party on the emerging technologies as per the requirements of the company.
- 20. **Guest Lectures**: Second Party to extend the necessary support to deliver guest lecturers to the students of the first party on the technology trends and in house requirements.
- 21. Curriculum Design: Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.
- 22. Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the terms specified herein
- 23. There is no financial commitment on the part of the second party to enroll the students for the different free trainings run by the second party under Everyday Learning Initiation.
- 24. In case, first party wants to conduct customized commercial trainings then this agreement can be amend/adding annexure with mutually agreed terms.

CLAUSE 3: INTELLECTUAL PROPERTY

- 25. The second party will have the sole rights on the curriculum and related content provided in the trainings and it cannot be replicated or copied without the consent of the second party.
- 26. Confidentiality: Except as may otherwise be required by law, each party will hold confidential, during and after the term of this Agreement, any confidential information

CLAUSE 4: VALIDITY

- 27. The period of the agreement is valid for a period of 1 year, from the date of signing of this agreement till 03 APRIL 2025
- 28. This agreement will be valid only at the intentions of the parties involved therein, this MOU could be dissolved or cancelled by either party any time by giving 10 days 'notice and shall not have any legal bindings in nature, should either or all the parties to it opt to not act upon, the MOU loses its validity.

CLAUSE 5: RELATIONSHIP BETWEEN THE PARTIES

29. It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

CLAUSE 6: Termination

30. Either party may terminate this agreement with written notice of 10 days if there is a breach of terms or for any other reasonable cause. This MoU is subject to the laws of the Jurisdiction of Mumbai and will come into effect upon the signatures of authorized representatives from both parties. We look forward to a fruitful collaboration and contribute to the professional development of our future workforce.
